# The Challenge

As a financial services provider, Privatbank has to comply with the PCI DSS standard which requires strict protection of card holder information. The bank also falls under the information security regulations of the National Bank of Ukraine. Both regulations require financial institutions to manage privileged access to the data of banking customers. In response, Privatbank's IT Security team expressed the need for a network security solution capable of managing and recording of the privileged users' (typically system administrators') remote activity. After the security team had managed to get the approval of the IT security management, it started to search for a Privileged Access Management solution on the market.

## **The Solution**

When searching for alternatives, Privatbank quickly found One Identity's privileged user monitoring appliance, the Safeguard for Privileged Sessions.

The full implementation project took only four weeks.
