Challenges

The bank needed to provide transparent account management in a heterogeneous environment that uses Microsoft Active Directory and Unix operating systems.

Administrators previously had to create user accounts, configure access policies, and carry out other actions manually on each Unix server. The addition of new hosts added to the load on administrators, increasing the time taken to diagnose faults.

The bank needed a solution that would automate these processes.

Use of group policies simplifies the work of IT specialists

After studying what was available on the market, UkrSibbank experts came across One Identity Authentication Services. BAKOTEK, which distributes One Identity software products in Ukraine, proposed One Identity Authentication Services as the perfect solution for authentication in Unix systems. It is also recommended and certified by Microsoft.

One Identity Authentication Services enables systems other than Windows, such as Unix and Linux, to become full members of an Active Directory domain. The solution implements Kerberos-authentication for these systems in the same way as in Windows. One Identity Authentication Services makes it possible to use group policies for Unix and Linux systems, and the additional group policies can be integrated with the native Microsoft Management Console (MMC).

Implementation of One Identity Authentication Services has enabled centralised management of user accounts. It is now possible to integrate user accounts from Unix servers to Microsoft Active Directory with full authentication and authorisation. A major benefit when using Active Directory is the additional functionality such as the group policy mechanism. This greatly simplifies account management and configuration of access rules.
